Workforce / People (4 Ps)

PACTs will bring together a skilled workforce of professionals across health and social care, supported by its own leadership team, to promote multi-disciplinary problem solving and use all available community assets

Services are already working together and are known as the PCN Aligned Core Teams (PACTs). There are 6 PACTs in West Essex.

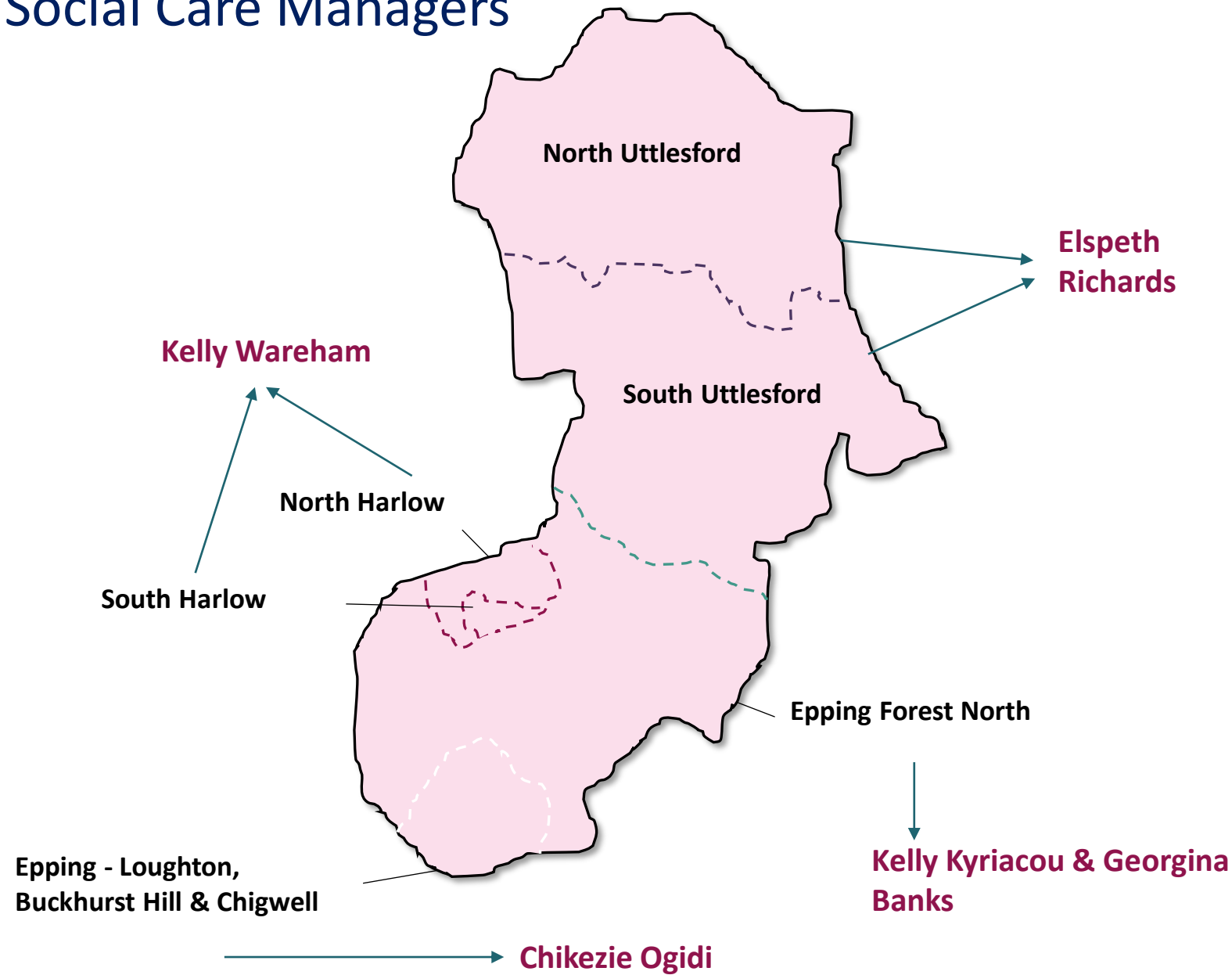


There is work underway to review access and coordination of health and social care services at a West Essex system level.
