This category recognises an individual who consistently provides good quality care, compassion, creativity, dedication and has a willingness to learn new skills and go the extra mile.



Lorriet Kadenhe, Estuary Housing Association Care & Support

Lorriet made a profound difference to the life of one of the individuals she supports. They were self-neglecting in all areas of their life and disengaged with life outside of their immediate surroundings, but with this outstanding support workers patience, creativity and kindness, Lorriet was able to connect with this person in ways that others hadn't been able to achieve. Over a 10-month period they encouraged, supported and motivated the individual to such an extent that they decorated their flat, got up, washed and dressed every day and even started to socialise outside of their flat. This outstanding support worker has worked hard and consistently cared with compassion, developing and using an impressive range of skills and always wondering what more they could do.

The judges stated Lorriet had supported such positive changes, which had clearly been life changing for the individual they supported and demonstrated relationship-based practice at its best.

The Kitchen Team at Alexandra House


The Kitchen team embodies the true spirit of a team, working diligently and compassionately behind the scenes in the care home kitchen, ensuring residents receive not just nourishments, but comfort, dignity and a sense of home.

What truly sets this team apart is their resident-centred approach. The head chef is often seen interacting with residents during mealtimes, getting residents feedback and making sure their preferences are met. He is also known as one of the resident's favourite entertainers – bringing joy through music, conversations, and meaningful engagement.

The kitchen team is also deeply embedded in the life of the home, participating in fundraisers, wellbeing walks, car wash events, and special celebrations like birthdays, and community events.

The team play a part in the induction process of any new member of staff in the home, they will have one to one allocated time with the team where they discuss the home expectations around food serving and nutritional needs of each resident.

This team doesn't just cook meals, they create moments of joy, security, and healing. For many of the residents, mealtime can be one of the few constants in their lives, and the kitchen team goes above and beyond to make those times feel safe and familiar.

PROSPER Award

This Award is open only to care homes who are on the Prosper project, which uses quality improvement methodology for the prevention of falls, pressure ulcers and UTI's. This award recognises those care homes who have made a significant impact on resident's quality of life by using the Prosper methodology and tools to drive change in their home.



Cheviot Nursing Home

The Prosper team at Cheviot Nursing Home clearly demonstrated their team's commitment to quality improvement and how the Prosper methodology is embedded in their daily practice. With the use of data, SMART Aims, Driver Diagrams and Root Cause Analysis they have created a culture of continuous improvement which has gone beyond the key focus areas of Prosper. They have implemented a vast array of interventions to help improve Residents quality of life, increasing hydration, improved Oral Healthcare, zero pressure ulcers and a reduction in falls. The nomination clearly evidenced the outcomes for residents.

Ageing Well for Adults with Disabilities

This award recognises a team who have demonstrated a proactive and person-centred approach to supporting individuals with a learning disability who have been identified as ageing.



The Family Team at Civicare East Ltd

The Family Team recognise the challenges an ageing population of people with disabilities faces. With age related conditions like dementia, which progresses at a faster rate, osteoporosis and diabetes, they have tailored their services and support to be appropriate for those with learning disabilities who may have co-morbidities and experiencing age-related changes, such as coping with the death of parents, social isolation and loneliness. They have focused on maintaining independence, promoting physical and mental well-being, and ensuring access to appropriate support services.

They use sensory boxes which staff take to people's homes to help them with reminiscence, sensory processing and development, maintaining fine motor skills, and cognitive abilities. They encourage physical activity, promoting regular exercise and movement which is tailored to individual capabilities, to maintain physical health and reduce the risk of secondary conditions. Civicare East's Family team employ a hydration champion, provide access to mental health support, including counselling, therapy, and support groups and have created their own 'First and Then Board' to support with routines and managing transitions. All employees are Dignity Champions and Dementia Friends and support individuals to create Life Story books and have discussions on End of life Care wishes. They have implemented national drivers and utilised the Ageing Well Toolkit with evidence of applying learning to practice.

The Judges stated it was clear to see how this organisation provides a holistic approach to care and how they manage health needs of an aging population of people with disabilities.

Dementia Care

This award recognises the provider who has demonstrated a proactive and person-centred approach to supporting individuals living with Dementia and is able to evidence a good understanding of the challenges they face and how they have improved their wellbeing.



Frank Foster House

Frank Foster House has demonstrated their commitment to Dementia care is not just about providing support but about transforming lives with compassion, innovation, and a deep commitment to person-centred care. The judges stated the warmth came through in the nomination. They have implemented Namaste Care, a holistic, sensory-based approach that brings comfort, dignity, and connection to residents living with advanced dementia. They have embraced technology to enrich daily life, using digital life storybooks, reminiscence apps and personalised music playlists, these innovations have reawakened memories, boosted mood, and increased daily engagement for many residents. They have reconnected residents with the wider community, introduced intergenerational programs with local schools, nurseries, and community groups. Through their life history work they have reignited old hobbies and restored lost confidence, enabling one resident to go swimming again, she not only swam again but beamed with pride and joy, sharing that she felt "like her old self again."

There were many testimonies from relatives remarking on how their loved ones were now thriving, enjoying life and the interactions in the care home.

Activities and Wellbeing

The Activities and Wellbeing award recognises the provider, individual or team who have taken a proactive approach to improving individual's wellbeing regularly through meaningful activities that are person centred. Creating an environment where individuals are engaged, stimulated, and fulfilled.



Jayvin Causapin, The Oaks

Jayvin Causapin is a creative and innovative individual who takes the time to truly get to know the Residents, listening carefully to their stories, preferences, and wishes, and then using this insight to create meaningful experiences for residents, families and staff.

He spends hours researching a wide range of activities and has an incredible gift of turning an ordinary day into something memorable and uplifting. From a conversation with a resident about memories of holidays in France he created a French themed day, dressed up as a French chef, brought in a crepe maker, and spent the afternoon cooking crepes with the residents, whilst recounting shared memories of France. He also gets staff involved and one sunny day with a mischievous plan, recruited residents to ambush staff in the garden with water balloons much to the residents delight!

Jayvin's nomination really shone through with the many examples of personalised activities and ability to create wonderful experiences on a small budget.



The Bungalow

The Bungalow have developed a wide range of community collaborations which are tailored to individual interests and hobbies. These are not just outings or experiences, but an affirmation of the individual's identity and time has clearly been taken to seek out opportunities that promote the individuals mental wellbeing giving them a sense of belonging in the community.

A powerful example is the support they secured for two residents who love swimming and physical activity. When one of the residents' parents could no longer afford the gym membership, one of the staff members took the initiative to approach the gym directly. Through thoughtful discussion and advocacy, they were able to obtain community sponsorship, granting the resident free and unlimited access to gym and swimming facilities.

The judges also highlighted the monthly "Wow!" event which is something residents can count down to and get excited about. These have ranged from wrestling matches and live theatre to The Elf performance and upcoming ABBA Voyage concert. These moments are planned with great care and passion and are often inspired by residents' suggestions, input from family members, or simply the staff teams creative thinking.

The Judges stated there was lots of evidence of individual tailoring and going the extra mile to help people realise dreams and enjoy activities of interest and passion.

Palliative Care

This award recognises an individual or service who provide a high-quality, person centred approach to palliative care, which optimises quality of life and recognises how choices made by the person being cared for and their family are central to the service and care that is delivered. Providing care, support, and comfort to those in the last year and last days of life.



Cheviot Nursing Home

Cheviot Nursing Home's approach to end-of-life care is not just about care and comfort but one that honours legacy, advocates for dignity, and makes sure no final moment is lost to silence. This home is accredited with the Gold Standards Framework for End-of-Life care and the judges stated their nomination demonstrated a real commitment to individualised care and wishes, supporting with complex issues such as mobility and equipment and the determination to provide a good quality of life until the end. They identified what was most important to the individual and made it happen, they weren't just an individual with a terminal diagnosis — they were someone who still had dreams, wishes and wanted to be immersed in laughter, connection, and community.

The care did not stop once they had passed, it was extended to the family with a memorial tea where Staff and family share memories. Their Children were given a Memory Bear made from a favourite jumper and their name lives on in the homes Memory Garden, where a daffodil blooms each spring.

Families receive a "Remember Me" Bag when a loved one dies — filled with forget-me-not seeds, bereavement resources, and a message of continued care from the home: "Grief doesn't end with death, and neither does our support."

Mental Health & Wellbeing

This award recognises a provider, organisation or individual who invests in the Mental Health and Wellbeing of their staff, clients, families and communities. An organisation or individual who has made a positive impact on supporting others who struggle with their mental health. Who values and encourages an open and positive culture to mental health and puts the wellbeing of others first.



Joseph Nursing Home

Joseph Nursing Home have put Mental Health at the heart of everything they do, recognising that mental health is as important as physical health. Their commitment to supporting the mental health of their staff and residents also extends to the families of residents and has been reflected in the real-life stories of those they support: from helping a lonely husband reunite with his wife in their care home, supporting him through his own ill health and struggles, to supporting a staff member through physical and emotional challenges, making adaptations to support their wellbeing, and welcoming back a nurse after a life-changing stroke with compassion, playing a key role in their recovery and successful reintegration into the workplace. Joseph Nursing Home shows they don't just talk about wellbeing, they live it every day.



Jackie Casey, Civicare East Ltd

Community Partnership and Collaboration

This category aims to recognise a provider who has worked in partnership with the community and/or other organisations, such as Health and social care to achieve the best outcomes for individual(s), integrating their service into the local community or adopting initiatives that encourage intergenerational interactions or support the wider Health and Social Care system.



The Key Player Team, Home Instead Braintree

The Key Player team spends a lot of time and effort in organising events and collaborating with the wider community to educate the public about Dementia, they partnered with Land Security who manage the Braintree Village shopping complex to organise a 3 day event, enlisting a wide range of organisations from the Alzheimer Society, Carers first, Solicitors and Friends of Braintree hospital to name but a few, who were there to help support and educate the public about Dementia.

On another occasion they arranged for the Virtual Dementia Tour bus to be accessed by the public and other community partners. They have worked with Braintree District Council to organise an 'Age Well' Fair canvassing for local pharmacies, podiatrists and health food shops to attend.

They are founder members of the Halstead Dementia Community, and they developed a What and Where guide which lists activities and groups that would appeal to the retired and elderly in the community.

The judges felt their dedication to supporting the community, people with Dementia, their families and carers was admirable.



Winner for Residential Care

Cherry Wood Grange

Cherry Wood Grange has created a vast array of opportunities for residents to engage with the wider community, making the Care home a valued part of that community.

They created the Forget-me-Not Café which now welcomes visitors from local care homes, schools, churches, community organisations, and volunteers of all ages, creating a rich tapestry of intergenerational interaction and mutual care. One resident said attending the café was like the old days, chatting with neighbours over tea.

As well as inviting the community into the care home they have partnered with Castledon School and the Aspire community Café which residents regularly attend and are served by students with additional needs. This experience provides meaningful interaction and learning for both groups. The home said "the Aspire Café is such a special place. Watching the students grow in confidence while our residents beam with joy is simply priceless."

Residents attend services and community events at several local churches and in return, church members attend the Forget Me Not Café, creating twoway spiritual and social enrichment.

With Book clubs, the Gents Pub Club and Beach School Explorers the Judges said there were many opportunities created for community partnership.

Equality, Diversity & Inclusion

The Equality, Diversity and Inclusion Award, celebrates an organisation who promotes the values and demonstrates a commitment to the spirit of equality, diversity and inclusion, through behaviour, positive interaction, leadership, and exceptional efforts to promote an inclusive environment for all.



Loganberry Lodge

Loganberry Lodge is a model of inclusivity, they have created a Multicultural Prayer Room available for residents, staff and visitors. Menus, feedback forms and service user guides are translated into different languages and staff work with families to create personalised communication cards for residents with limited English. The home has LGBTQI+ champions and one resident, who had previously experienced discrimination in another home, was supported gently and sensitively. LGBTQ+ staff offered one-to-one conversations, and awareness was raised at residents' meetings. This helped him feel safe enough to come out and have his partner visit openly. He expressed deep gratitude for this acceptance before his passing.

The home enabled an Italian resident, who was a retired Michelin-starred chef, to work alongside kitchen staff to help shape the menu. With support from head office, they even organised a fine dining experience with professional chefs for him and fellow residents to enjoy.

The judges said this was an excellent submission with all areas of Equality, Diversity and Inclusion covered, including both staff and residents.



Civicare East Ltd Mundy House

Digital Impact & Technology

This award recognises providers who have embraced new technologies and used digital solutions to keep the people they provide a service to safe and well. Connecting workforces, individual(s) or strengthening relationships with partner organisation through technological and digital solutions, which could be aimed at prevention, maintaining independence, improving wellbeing, early identification of deterioration or making improvements in how the service is run.



Mundy House

Mundy House has a strong mix of technologies implemented across the home that supports residents' health and wellbeing. Their use of Digital Listener devices has helped bridge communication gaps between residents and their loved ones. Digital monitoring of vital health stats, using the Whzan technology, acts as early detection, supporting the GP surgery and ensuring residents get early intervention at the first signs of being unwell. Medication Management has been streamlined with direct digital access to the surgery reducing medication wastage and preventing delays in obtaining prescriptions.

Residents are supported with a whole host of digital devices such as tablets, mobile phones, laptops and audio equipment all of which help residents to maintain relationships, independence and joy in their daily lives. Residents can have Alexa set up in their rooms to give them easy access to music, weather updates, audiobooks, jokes, prayers and direct calls to family members. Digital Activities are freely available with the use of extra-large screen Rainbow Tablets that have games, puzzles, music, drawing and virtual instruments.

The home has installed a digital parking system to ensure space for the people who matter the most such as family members or visiting professionals and they have even created their own You Tube Channel which now has over 300 subscribers.



Millard House

Climate Action: Towards Net Zero

This award recognises an organisation who has a proactive approach to supporting action to stop Climate change. Using innovative initiatives to help Essex to become net zero by 2050, making climate change sustainable by reducing carbon in care settings and environments.



Lambwood Heights

Lambwood Heights have created an established climate culture by intertwining sustainability within their company values, they have a designated 'Green Committee' who meet quarterly to arrange green activities and plan initiatives and have won the Green World Award 3 years in a row, they have maintained their focus and increased efforts to continue to achieve the highest level of sustainability in the sector. With a Green mark Level 3 certification, the highest level available and certified as a Carbon Neutral Business 4 years running, they are proudly establishing themselves as front runners in the social care sector.

In 2024 they took time out from their busy roles to plant over one thousand trees as part of the Essex Forest Initiative and staff members use the TREEKLY app, so that mangrove trees can get planted for each step count they achieve.

As well as their many green initiatives which range from zero landfill to 100% recycled carbon neutral toilet tissue, they hold educational talks in the home about biodiversity and the eco-system with their Bee Talk Day.
